- Treasurer's report
  - \$21 in donations received since last meeting: \$20 donation, \$1 from PayPal giving fund
  - \$110 in expenditures since last meeting: \$90 for 3 month GrantWatch subscription, \$20 for annual LARA license
  - 2 \$5000 3-month CDs purchased from LOSB (01 September 2023 01 March 2024)
    - 6 month at 2.25% interest, estimated interest to be earned at maturation is \$112.82
    - CDs will auto-roll if not cashed out at maturation
    - both CDs are secured in fireproof lockbox at Treasurer's residence
  - Treasurer continues to fine-tune chart of accounts in QuickBooks

  - GrantWatch 90 day subscription purchased; the following grants are grants identified that we may qualify for
    - PIG Difference Grant
      - focused on restoration, conservation and protection through projects executed, not for research
      - first deadline is 14 October; multiple deadlines throughout the year

      - missed the September deadline
      - next deadline for application is 15 March 2024
    - Great Lakes Energy People Fund Grant
      - Lisa will check to see if BLAEP is eligible and competitive
    - James M. Cox Foundation

- Grass Roots Fisheries Habitat Improvement Projects
  - deadline was 18 September, but extension granted to Friday, 22 September due to technology based communication breakdown
  - grant maximum is \$25,000 for hands-on type project (not research), matching funds are desired but not required
  - DNR endorsement letter required to be included in completed application package
    - Joe Noehner of Michigan DNR to provide endorsement letter
    - Lisa working to finalize application for submission to meet 22 Sep 2023 deadline

  - line by line review of potential sponsors list conducted
